3. Sealed Quotation forms may be purchased by eligible bidders on the submission of a written application and upon payment of a non refundable fee of 1000.0 NRs.

4. Sealed bids must be submitted to the office Brahmpuri Rural Municipality, Sarlahi by *hand* on or before 12.00 on **02-June-2026(2083-02-19)**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **02-June-2026(2083-02-19) and 13.00** at the office of *Brahmpuri Rural Municipality*. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **34,000.00 Nrs**, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. **21701017500017** at [**Nabil Bank Ltd. , Brahmpuri, Sarlahi**] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
